



## Special conditions DAZN Viking Pass

1. These special conditions relating to the DAZN Viking Pass apply, in addition to the [General Terms and Conditions](#), to all aspects of the relationship between the Viking and Mobile Vikings regarding the DAZN Viking Pass.
2. The DAZN Viking Pass provides access to a discounted DAZN Total subscription, combined with specifically selected beneficial Viking Deals.
3. Discounts are only granted to Vikings with an active Mobile Vikings mobile and/or internet at home subscription. A prepaid card combined with a DAZN Viking Pass does not entitle you to a discount.
4. The DAZN Viking Pass consists of (i) access to DAZN, and (ii) access to beneficial Viking Deals.

### **1. Access to DAZN**

- a. By linking your DAZN subscription (existing or new) to Mobile Vikings, you are entitled to a monthly discount of € 5, shown on your Mobile Vikings invoice/payment invitation.

The link to Mobile Vikings can only be made for monthly DAZN subscriptions, not yearly subscriptions. If you already have an active DAZN subscription, you can still link it, but only via a monthly subscription through Mobile Vikings. In that case, check article 4.1.C below for the impact on your existing yearly subscription.

- b. To use the DAZN Viking Pass, you need a DAZN account, which you can activate via the [DAZN website](#). You must also accept [DAZN's general terms and conditions](#).

DAZN may make changes to the DAZN service, in accordance with its own [terms and conditions](#).

- c. You can link an existing DAZN subscription to Mobile Vikings via the steps described in your My Viking account or related emails. You can manage or cancel your DAZN Viking Pass in your My Viking account.



If you already have a DAZN subscription and choose to continue it via Mobile Vikings, your current yearly or monthly subscription will be immediately terminated by DAZN. Contact [DAZN customer support](#) about a possible refund.

If your current DAZN subscription was taken via a third party, it will remain active as well and must be cancelled by you with that third party. In both cases, your DAZN Viking Pass becomes active immediately.

For questions about the status or billing of your DAZN subscription, contact [DAZN customer support](#) directly.

- d. After the first 30 days, you can cancel your DAZN Viking Pass at any time, free of charge, via your My Viking account. Cancellation always takes effect at the end of the current subscription month.
- e. If you cancel your Mobile Vikings telecom service(s), access to DAZN via Mobile Vikings will also end at the end of the current subscription month. If you wish to continue using DAZN, you can subscribe directly with DAZN.
- f. DAZN manages and is responsible for the DAZN app and acts as data controller for the processing of your personal data in offering you the DAZN service, in accordance with [DAZN's privacy policy](#).

- g. Mobile Vikings is not responsible for issues or outages related to the DAZN app. In case of problems, contact [DAZN customer support](#) directly.

## **2. Beneficial Viking Deals**

- a. The DAZN Viking Pass also gives access to a selection of beneficial Viking Deals, as indicated on the [Viking Deals website](#) and Mobile Vikings communication channels.
- b. Viking Deals are subject to specific terms and a specific [privacy statement](#).
- c. The selection of DAZN-related beneficial Viking Deals may change depending on availability with partners. You accept that this selection of Viking Deals and the related benefits may evolve over time and that availability of a specific Viking Deal does not create any right to that Viking Deal. Conditions linked to a beneficial Viking Deal linked to the DAZN Viking Pass (e.g. number of Viking



Points granted) may also vary. Availability of any Viking Deal is not an essential element for the execution of the DAZN Viking Pass agreement.

5. Mobile Vikings may change how the DAZN Viking Pass is offered and its conditions, e.g. pricing. If these changes affect you, you will be informed in due time. You always have the right to cancel your subscription free of charge.
