



Special conditions Deezer via Mobile Vikings

1. These special terms and conditions regarding Deezer apply, in addition to the provisions of the [General Terms and Conditions](#), to all aspects of the relationship between the Viking and Mobile Vikings in connection with Deezer.
2. By linking your Deezer subscription to Mobile Vikings, you are entitled to a 1-month free trial of Deezer. After the trial period, the Deezer subscription automatically becomes a paid subscription and you will be entitled to a monthly discount of € 3.50, which will be shown on your Mobile Vikings invoice/payment invitation.

The 1-month free trial of Deezer is exclusively available to new Deezer customers and can only be claimed once.

These terms and conditions apply when linking a monthly Deezer Premium or Deezer Family subscription.

3. You can only link monthly Deezer subscriptions to Mobile Vikings, not annual subscriptions. If you already have an active annual subscription with Deezer, you can still link a subscription, but only a monthly subscription via Mobile Vikings. In that case, make sure to check the consequences for your existing annual subscription in Article 6 below.
4. The discount is only granted to Vikings with an active Mobile Vikings mobile subscription and/or internet at home subscription. Combining a prepaid card with Deezer, for example, does not entitle you to a discount.
5. Your Deezer subscription (including the free month of Deezer) becomes active when you link it in My Viking and becomes a paid subscription after the trial period. To actually use Deezer, you then need a Deezer account, which you must activate [via your My Viking account](#). At that point, you must also agree to the [Deezer Terms and Conditions](#).

If you link your subscription in My Viking but do not activate it on the Deezer website, we will cancel your order within 30 days to prevent you from continuing to pay for a service you are not using.

If you later wish to subscribe to Deezer via Mobile Vikings again, you will not be entitled to another free month of Deezer.

6. You can link a Deezer subscription to Mobile Vikings by following the steps provided in your My Viking account or in the relevant emails. You can continue to manage or cancel your Deezer subscription free of charge in your My Viking account.



If you already have a subscription with Deezer and want to continue it via Mobile Vikings, you must cancel your existing Deezer subscription in accordance with the [Deezer Terms and Conditions](#) and activate the new subscription via Mobile Vikings after your current subscription period has ended. This ensures that, when your new subscription via Mobile Vikings starts, you only start paying through your Mobile Vikings invoice/payment invitation.

7. You can cancel your Deezer subscription at any time, free of charge, in your My Viking account. Cancellation of the Deezer subscription always takes effect at the end of the current subscription period. If you cancel your telecom service(s) with Mobile Vikings, your Deezer subscription via Mobile Vikings will also automatically end at the end of the current subscription period. If you still want to use Deezer afterwards, you can subscribe directly through Deezer.
8. DEEZER SA is the data controller responsible for processing your personal data in order to provide you with the Deezer service, in accordance with the [Deezer Privacy Policy](#).
